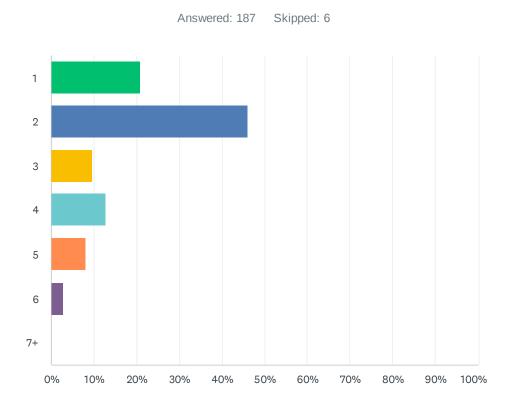

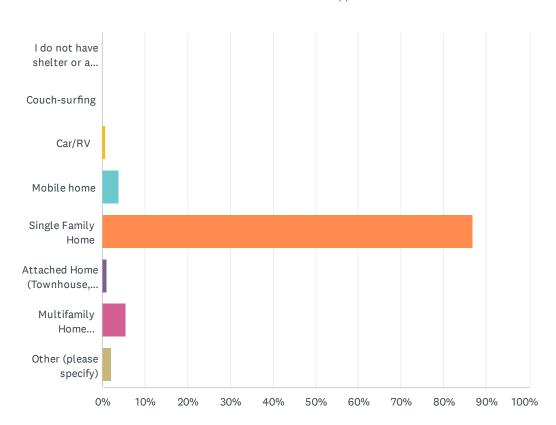
Q8 How many people live in your household?

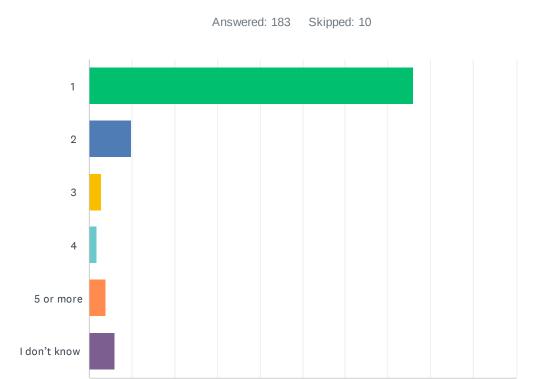

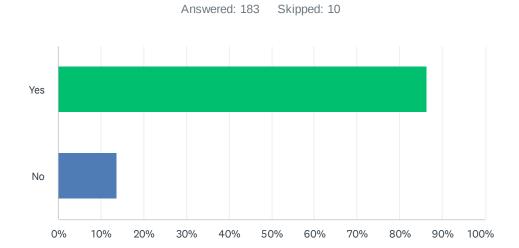

Q11 Are you satisfied with your current housing situation?

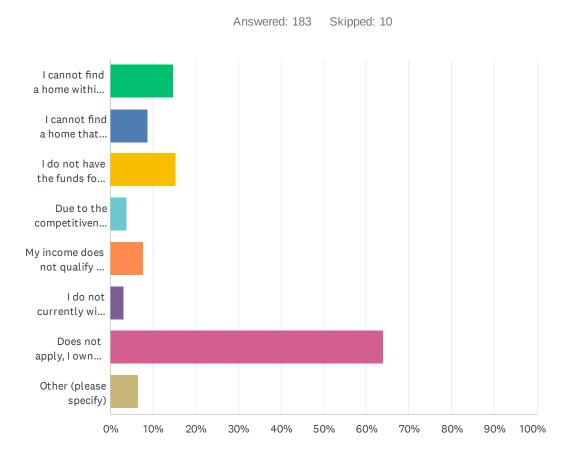

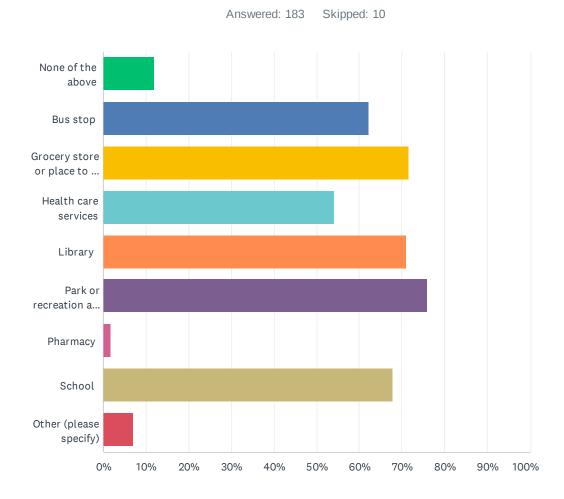
